

Public Notification for Deregistration from Political Party and Transfer of Gung/Mitsi

As per Sections 100 (b) and 206 (d) of the Election Act of the Kingdom, 2008, the Election Commission of Bhutan (ECB) would like to inform the general public that the incumbent members of the Dzongkhag Thromde Tshogde in Samdrup Jongkhar and 205 Gewogs of Bhutan will be completing their five-year term in January 2027.

Therefore, the ECB would like to remind all individuals who wish to vote from the Dzongkhag Thromde in Samdrup Jongkhar or 205 Gewogs and/or contest for positions in the Dzongkhag Thromde Tshogde and Gewog Tshogdes in 2027 to take the following necessary actions with immediate effect:

1. Get/have their names checked for party affiliation either with the concerned political parties or at the ECB website and deregister from the membership list of the political parties; and
2. Initiate the Gung/Mitsi transfer in order to have the Gung/Mitsi registered in the civil registry of the new constituency for not less than one year before the qualifying date.

The ECB urges all aspiring individuals to initiate and complete the above requirements on or before 31st January 2026, well in advance for smooth participation in the elections.

Greetings from the Democracy House of the Election Commission of Bhutan!

In compliance with Executive Order No. ACC/COM-11/2746 dated December 2022, and subsequent Notification on the requirement for Integrity Vetting Report (IVR) date June 19, 2025, issued by Anti-Corruption Commission (ACC), the Election Commission of Bhutan (ECB) would like to inform Dashos that henceforth all aspiring candidates contesting for different levels of positions in Local Government elections must mandatorily obtain an Integrity Vetting Report (IVR) from the ACC.

This requirement has become imperative in ensuring that interested individuals contesting for elective posts uphold the highest standards of integrity and accountability.

In this regard, all Dasho Dzongdags are kindly requested to disseminate this important information to the Gewog Administrations under your Dzongkhag at the earliest convenience. The Gewog Administrations should be advised to further disseminate the general public within their jurisdictions about this mandatory requirement to avoid any inconveniences during the future election processes.

Dasho may advise that for further clarification or assistance regarding the IVR process, concerned individuals may contact Chief Human Resource Officer (CHRO) of the ECB who is appointed as the Focal Person.


