1. Background

Forests, as a vital component of ecological wealth, play a crucial role in the socio-economic development and environmental well-being of the country. Recognizing their ecological significance, forest conservation has been prioritized, and robust policy frameworks have been established to protect these natural resources. The Constitution of the Kingdom underscores this commitment by mandating that at least 60 percent of the country's land area remain under forest cover. Thus, Article 5 of the Constitution of Bhutan states that "Every Bhutanese is a trustee of the Kingdom's natural resources and environment and it is the fundamental duty of every citizen to contribute to the protection of the natural environment, conservation of the rich biodiversity of Bhutan". Currently, approximately 69.71 percent of the nation's geographical area is under the forest cover.

However, forests continue to face persistent threats from deforestation and degradation, driven by various factors such as forest pests and diseases, wildfires, rising demand for timber, and developmental activities. Among these, forest fires pose the most significant threat, challenging the Constitutional mandate to maintain 60 percent forest cover. The prevalence of coniferous forests, coupled with the country's steep and rugged terrain, makes effective fire suppression extremely difficult.

Paro Dzongkhag is no exception in the risk of forest. Paro Dzongkhag has 53.50 percent under forest cover out of which 37 percent is Fir, 26 percent Blue pine and 14 percent hemlock forest (Table 1).

Due to its high coverage by conifer forests especially blue pine forest coupled with high land surface temperature and low rainfall in the valley, risk of forest fire is imminent and difficult to control.




Figure 1. Trend of Forest fire from 2018 to 2025.




Figure 2. Forest fire frequency by forest types

The trend of forest fire has been increasing as per the record from 2018 to 2025 (Figure 1). Most of the forest fire have occurred in blue pine forests due to the high inflammability and proximity to the settlement (Figure 2).

In alignment with the Constitutional mandate that emphasizes the fundamental duty of every citizen to protect the natural environment, the Inter-Agency Forest

Fire Coordination Group (IFFCG) was first established in 2017 in Thimphu Dzongkhag. Thus, Paro Dzongkhag has developed this Standard Operating Procedure to foster collaboration among various agencies including local communities in forest fire prevention and suppression efforts in the Dzongkhag.

1.1. Objectives

The objectives of the SoP are:

- i. For better coordination among stake holders to prevent forest fire.
- ii. To enhance immediate response to forest fire and ensure the safety of firefighters.
- iii. To facilitate efficient coordination between stakeholders during forest fire incidents and optimal allocation of resources for all forest fire suppression activities.
- iv. To delineate roles and responsibilities for the IFFCG members.

1.2. Groups

The IFFCG shall have a Coordination Group and a Rapid Response Team.

i) Coordination Group

The Coordination Group shall discuss and plan to prevent forest fires, and also coordinate and mobilize manpower and resources at the time of forest fire depending on the severity of the incident. The group shall have a chat group in any of social media platform for discussions or information sharing at all times. The IFFCG shall make medical support team available if incase medical emergencies arise. The group shall conduct regular meetings to share experiences and plan way forward. The group shall comprise of the following members (Table 2).

ii) Rapid Response Team

The Rapid Response Team is formed for immediate response to forest fire incidence. The group shall attempt for immediate suppression of fire and update the situation to the Coordination Group for further support, if needed. The group shall also conduct preliminary investigation on cause of forest fire. The group shall comprise of officials from the following offices (Table 3).

Three stages shall be followed to address the forest fire. They are forest fire prevention, forest fire suppression and post fire management.

2. Forest fire prevention

2.1. Capacity building

Considering safety concerns and requirement of effective command system, the Dzongkhag Administration and Divisional Forest Office shall plan and organize training on firefighting techniques, use of equipment handling and communication protocol, etc., for the Rapid Response Team members. The Divisional Forest office and Dzongkhag Administration will source fund for the trainings in collaboration with the DoFPS and Department of Local Governance and Disaster Management (DLGDM). In addition, the Divisional Forest Office will train Rapid Response Team and other stakeholders from member agencies and local communities on prescribed burning techniques and fireline creation.

2.2. Awareness programs

The Divisional Forest Office and Dzongkhag Administration shall create awareness on forest fire prevention through various media such as BBSC, local TV channels and social media regularly before the onset of the dry season. The Gewogs shall create awareness to local communities to refrain from debris burning, campfire and *sang* offerings in their respective Gewogs during dry season. The Gewog shall issue permit for agriculture debris burning where necessary and intimate to the Divisional Forest office.

The Divisional Forest office shall create awareness on forest fire prevention during meetings organized at the Gewogs and Dzongkhag in collaboration with Gups and DDMO.

2.3. **Monitoring**

The Bhutan Power Corporation (BPC) Limited shall monitor and clear right of way along the transmission lines between October and December to reduce risk of forest fire. The BPC shall also construct concrete bases and clear bushes around the transformers before the onset of dry season. The Divisional Forest Office, Paro, shall facilitate the removal of forest produce along the transmission lines that pose a risk of forest fire ignition. DFO, Paro and Gewogs shall regularly monitor any incidence of forest fire during the dry season especially around the settlements and lhakhangs. Local communities should also monitor regularly and

report any incidence of forest fire to the Gewog Administration or RBP for further action.

2.4. Infrastructures

The Dzongkhag and Gewogs shall plan and construct water reservoirs around lhakhangs and national monuments and cluster settlements, and mapped for use during fire emergencies. These water sources will support firefighting efforts through the deployment of fire engines, water pumps, and water bags in the event of a fire disaster. Community lhakhangs and private lhakhangs shall construct water reservoirs or ponds near their lhakhangs and the DFO and Gewogs shall monitor and report to the Dzongkhag Administration.

2.5. Creation and maintenance of fireline

Settlements and monuments located near forested areas are particularly vulnerable to the threat of forest fires, making the creation of fire lines a critical preventive measure. DFO Paro and Gewogs shall identify potential risk areas around national monuments and settlements to create fireline and reduce this risk of forest fire. Gewogs in collaboration with Dzongkhag administration shall plan and mobilize resources and man power, whereas, DFO, Paro shall provide technical support. Gewogs shall coordinate annual maintenance of fireline around the settlements and community lhakhang.

2.6. Tools and Equipment

The Dzongkhag Administration and Divisional Forest Office shall give priority for supply of personal protective equipment (PPEs) and tools for the Rapid Response team members. In addition, it shall be the responsibility of the member agencies to purchase equipment if there is fund provision or propose budget. The Divisional Forest Office shall also facilitate to supply of equipment depending on the availability of fund. Following are list of basic tools for rapid response teams (Table 4). The leader of response team for respective offices shall maintain the stock register and record of issue and ensure they are returned after the forest fire. The IFFCG members shall explore fund and procure firefighting tools and equipment for use by the fire fighters (Table 5).

2.7. Coordination meeting

The IFFCG coordination meeting shall be organized by the Divisional Forest office and Dzongkhag Administration at least twice in a year to address issues and plan way forward to strengthen the IFFCG.

3. Forest Fire Suppression

3.1. Communication and coordination during the forest fire

Effective communication is important to provide efficient and reliable information on the onset as well as during the incident to mobilize man power and resources. Therefore, IFFCG communication flow is important. On the first information of the forest fire incident, IFFCG members shall immediately communicate with each other and plan to deploy firefighters at an agreed strategic point. All IFFCG members are responsible for coordinating communication for their respective agencies and in the IFFCG.

3.2. Logistic coordination during the forest fire

The Dzongkhag Disaster Management Officer with advice from the Incident Commander and in coordination with the Divisional representative shall coordinate logistic during the forest fire suppression.

The Dasho Dzongdag shall be the overall Incident Commander of forest fire. In his absence, Dzongrab shall substitute as an Incident Commander.

3.3. Operational procedure for the forest fire incident management

On the first day of the incidence

- 1. Any member of the two groups getting the first hand information shall immediately inform both the Coordination Group and the Rapid Response Team through phone or Whatsapp group on the occurrence of a forest fire.
- 2. The Rapid Response Team led by the a representative from the Divisional Forest Office shall visit the forest fire site immediately for situation assessment and suppression by involving local people of the area without having to wait for the instruction from the Coordination Group (Figure 4). The Response team shall form a team to collect evidence on the occurrence of forest fire through a preliminary investigation.
- 3. The Divisional Forest Office will lead the investigation supported by the RBP on the cause of forest fire from the first day of forest fire incident for necessary action.
- 4. The Rapid Response Team led by Divisional Forest office shall report to the Coordination Group on the status of the fire and update on the requirement of manpower or resources.

- 5. The Coordination Group shall coordinate resource mobilization and wait for information from the Rapid Response Team.
- 6. If the fire is beyond control of the Rapid Response Team, the Rapid Response Team shall report to the Coordination Group. The Coordination Team will then mobilize additional manpower and resources (tankers, fire engine, etc) wherever accessible.
- 7. An Agency deploying manpower for fire fighting must send their people with necessary equipment in teams with a team leader. Each team from an agency must report to the Incident Commander or authorized representative at the indicated vantage point.

On the subsequent days

- 8. If the firefighting operation extends over more days, the Chief Forestry Officer or Divisional representative shall give the *Situation Report* to the Incident Commander in the Coordination Group and recommend for estimated number of manpower, resources required and deployment modality with time and indicate place of reporting at vantage points.
- 9. The Coordination Group members shall then mobilize the manpower and resources for the following days as per the recommendation.
- 10. The Dzongkhag Disaster Management Officer (DDMO) shall facilitate the arrangement of logistics for the firefighters. In the absence of the DDMO, the respective Gewog Administrative Officer shall coordinate these arrangements in consultation with the DDMO.
- 11. The firefighters must report at the indicated vantage point for briefing for the day on mentioned timing/ time.
- 12. The Incident Commander/authorized representative shall brief the firefighters on direction of firefighting, personal safety, team work, equipment handling, and place and time of reporting back in the evening.
- 13. In case of deployment of man power for night duty, concerned Gewogs shall nominate local communities in collaboration with RBP.




Figure 3. Incident coordination system during forest fire

4. Post fire action

The Divisional Forest Office shall assess the impact of forest fire and submit Forest Fire Report in a prescribed format to the DoFPS with a copy to the IFFCG. DFO, Paro along with RBP shall prepare detail investigation report and submit to coordination group. The Division shall appraise the Department for post fire management activities such as extraction of fire burnt trees and plantation.
